

Are You A Wounded Warrior? Were You Hired On or After November 5, 2016?

You may be eligible to receive Wounded Warrior Leave as permitted by the Wounded Warrior Leave Act of 2015. This act, which passed in the United States Senate unanimously, helps wounded vets ease back into civilian life by providing additional leave benefits to care for their service-related disabilities.

The following summary was written by the Congressional Research Service and was published on November 6, 2015:

Wounded Warriors Federal Leave Act of 2015

(Sec. 2) Entitles any federal employee who is a veteran with a service-connected disability rated at 30% or more, during the 12-month period beginning on the first day of employment, to up to 104 hours of leave, without loss or reduction in pay, for purposes of undergoing medical treatment for such disability for which sick leave could regularly be used. Requires the forfeiture of any such leave that is not used during such 12-month period.

Requires such employee to submit to the head of the employing agency certification that such employee used such leave for purposes of being furnished treatment for such disability by a health care provider.

Let's Talk

As postal employees, we work for an organization whose primary mission is communication and yet, the Postal Service does not excel at communicating with its employees. There are many times when managers issue an order and have little-to-no details to share and can't answer the simplest questions like, "why?" As Union members, we are also in the business of communicating; like the Board does with you through this magazine, our website, and the various meetings we hold. As humans, we are in the business of communication. Relationships depend on and feed off of communication. Whether it's between management and employees, between members of this Union, between your State Board and you, or be-

tween you and your significant other; communication is key. As humans, we are social creatures and as humans in the 21st Century with our social networking,

you'd think we would excel at communicating and yet, it's one of those things that many seem to struggle with. Myself included. And so, I'm issuing a challenge to myself, this Union, and to everyone else to make a concerted effort to better our communication. To encourage that effort, I've included a few tips on ways to improve communication.

Listen.

Many of us think we're listening to others when, in fact, we're using that time to think of what we're going to say next. When the other person speaks, hit the pause button on your thoughts and simply listen to what the other person has to say. Don't interrupt and don't get defensive, instead just hear the person out and imagine what it is like to be in their shoes. When it's your turn to talk, reiterate what it is you've heard for confirmation that what you've understood is actually what the other person has said.

Talk with, don't speak to.

Communication is a two-way street. Don't dominate the conversation. Be sure to include others by encouraging them to voice their thoughts. We often think that communication is an opportunity to inform

others, when in fact it's an opportunity to be informed.

Be empathetic.

If you've truly listened to a person and understood their point of view, then you should be empathetic to their situation. Express that empathy. Make sure that they know, that you know.

Fess up.

If you've done someone wrong, then fess up to it. Take responsibility for what's yours. Admitting to wronging someone else is cathartic, will allow the other person's defenses to come down and will open avenues to mutual understanding.

If things get heated, cool off.

Communication breaks down when it's coming from a place of anger or hurt. In times like these, it's a good idea to take a time out. Very little can be re-

solved when two people aren't coming at a situation with level heads and even tempers.

It's how you say it.

When it comes to communicating, it's often about how you say it and less about what you say. There are many non-verbal cues that might lead someone to perceive something other than what you are saying verbally. Facial expressions such as scowls, smirks, and the rolling of eyes and gesticulations such as pointing and hacking at the air are counterproductive to effective communication. Tone matters too. Watch your tone whether you're communicating verbally or in written form. It is far too easy to lose sight of the above tips, especially when communicating online and while emailing. The same rules apply whether you're face to face or miles apart.

In the end, it pays to remember one thing: Communication is at its best when we communicate. So often, the problem lies not with the way we communicate but with our unwillingness to communicate in the first place. To encourage communication between you and your State Board I would ask that you communicate with us in whatever way you are most

comfortable; be it via phone, email, mail, or in person. The lines of communication are open, so come on, let's talk.



Are You Waiting for Someone Else to Fix Things?

These are uncertain times. The recent Presidential election proved that; even the so-called "experts" were caught off guard. That same uncertainty can be applied to the Post Office. We had all hoped that by now Congress would have come up with some form of legislation that would have dealt with the prefunding requirement and the other problems facing our employer. But that hasn't happened, and there is no real end in sight. Amazon deliveries have become a huge part of our jobs. Will that continue to grow, or will drones or other delivery options take that work away from us? We have been assured that new delivery vehicles are coming to replace the old, worn out ones we use now, but that time keeps getting pushed further and further away. The Post Office and the NRLCA are jointly working on an engineered time

study that may revolutionize our evaluated pay sys-/ tem, but the issue has proven so complex that it is taking much longer than expected.

The PO 603. How many of you have pulled it out lately and taken the time to reread it?

Questions and more questions. It's easy to feel lost sometimes when surrounded by uncertainty; to lose focus on what your priorities should be. Your job is to deliver the mail as safely and efficiently as you can. Period. Unfortunately, we often deal with postmasters and supervisors who, when faced with uncertainty, don't react very well when the rules keep changing or the pressure from above gets to be too much. Some managers become apathetic while others become bullies. The recent Christmas chaos brought out the worst in a lot of managers.

What can you do when faced with a supervisor who is unresponsive when you need something, or worse yet, believes the best way to get things done is through intimidation and harassment? A lot of you know what the answer is, but are unwilling to make

it happen. The answer is to know, for certain, what your rights and responsibilities are. The answer is not to roll over and take it, and is not to complain and complain but never do anything about it. The answer is not to wait for someone else to fix it.

The place to start should be right there at your case. The PO-603. How many of you have pulled it out lately and taken the time to reread it? You may be surprised at some of the things you have forgotten about how your job should be done. The language in there is considered contractual, and don't let your supervisor tell you otherwise. The next place you should go is the National Agreement itself. Your Union just sent you a copy of it. Did you read it? Did you even keep it? These are the working rules the Post Office has agreed to abide by. It doesn't matter if

> your Postmaster or Supervisor doesn't like any of the ·language in the Contract; their bosses agreed to it, and it doesn't hurt to remind them of that fact. But you need to read that

Agreement, understand it, and be willing to use it when you need it.

The next place to learn how to deal with issues at work is to become a participant. Go to your Union meetings. You always get a meeting notice at least 15 days in advance, and the information is on the website. The meetings are a great place to associate with fellow members who are most likely experiencing the same kinds of things you are. We always give out the latest information, and you can learn a lot just by being there. But the meetings are not as productive if the same few members are the only ones who show up. Or why not consider becoming a Local Steward in your office if you currently don't have one? There is no better way to learn about the Contract or how the workplace should be run than by taking the step

to help your fellow carriers by being a Steward. The information on how to go about doing that can be found elsewhere in this paper.

The best thing you can do, though, is to care. Care enough to get involved, care enough to learn the

things you need to learn, care enough to put those things you have learned into practice. Don't wait for someone else to fix things. That may never happen.

Get INformed. Get INvolved. Get IN on it.

Careful, Far-Sighted Bunch Provident Guild

You may be asking yourself what a "Careful, Far-Sighted Bunch" has to do with the Provident Guild. I put off writing this article for our last edition of the WRC because I didn't feel I knew or understood what the Provident Guild actually was or did. Oh, we all know the basics, but I thought I should know more in order to ask you to join. The first step in my search was to look up the actual Webster dictionary meaning, then the Thesaurus for more options. Hence the title.

The conception of the Rural Carriers' Provident Guild took place at Mt Vernon, Ohio in July of 1931.

In 1948 the Guild became the official Death Benefit Department of the National Rural Letter Carriers' Association. The stated purpose of the Guild is, "This is a fraternal, death benefit organization in

which membership is open to all regular, substitute RCR, RCA, and PTF rural carriers and their spouses, who are under 56 years of age".

I didn't pay much attention to this until now. And oops! I missed that window. I wish I had paid more attention when this information was first presented to me.

The annual payment, which never goes up, varies from \$10 to \$50, depending on your age when signing up, with the final payout amount ranging from \$1,000 to \$5,000. The important thing to remember is that this is a death benefit. You have 30 days to sub-

mit the required forms and a copy of the death certificate in order to receive the benefits.

The death of a loved one under any circumstance is unbelievably difficult. The sudden unexpected loss of a loved one can truly set you on your rump. As we have all been aware of in the past few years, it happens more often that we would like. Speaking from experience in both instances, a little quick cash can sometimes make a big difference. The 30% payout at the time of death may not seem like much right now, but it could be the difference between paying a few bills or not. Life around us always continues on and

the reality of life is that those pesky bills won't wait. There are several other examples I could give you, but I am sure you get the point. The remaining balance is paid

out after the next National Convention. Let me reiterate that you have 30 days from the time of death to file the necessary forms.

One thing I learned from my losses is that no matter how well you think you are prepared and have your affairs in order, you probably are not. Put all of the information regarding your banking accounts, life insurance/death benefits, and any other pertinent information on a thumb drive, and put that in a designated spot that family members are aware of. When the need arises, that one little action could be of a great help to your loved ones.



Are You A Klutz Like Me?

My yelp when I stepped on a marble woke the entire house up just fine! "Where did that come from?" I wondered! I still am unsure of where it came from to be honest, but I know that had I turned the light on, I probably

would not have stepped on it, because I would have seen it and likely I would not have disturbed those who were asleep with the minimal light either. Poor lighting is a common cause for slips, trips, and falls.

Would you join with me by making it a goal in 2017 to practice the same safety precautions at home ... ?

Do you have stairs? Do you find yourself coming up or down the stairs and forget something and think to yourself, "I will just set this here for a moment and then pick it up." Then you forget to pick it up and it is <u>still</u> there, right now, as you read this? It's ok. You are not alone. I do that too. But, clutter on stairways and in hallways is a potential hazard that could lead to a slip, trip, or fall. It is a bad habit to get into. Remember to always, always keep your staircases and hallways clutter free!

Is your bathtub or shower safe? Do you have nonskid mats on the floor? Do you have a support bar to hang on to as you get in and out? If not, why not? This is another common place in the home for slips, trips, and falls. The bottom may look like it is clean, but there is usually some sort of soap residue left and when it gets wet again, becomes very slip-

pery. An unsuspecting step could land you in a heap before you know it! It is very easy to avoid by placing nonskid mats or nonskid adhesive stickers to the floor of the tub or shower.

What do you do when you are in the kitchen cooking and you need some water in the pan right away and between the sink and the stove, a bit of water spills on the floor? Do you immediately wipe up that spill or think to yourself, I will get that in a bit as soon as I get the rest of the dishes taken care of? If you are me, the KLUTZ, you think the latter, and then find yourself skating across the kitchen at a demonic speed when you hit that puddle of water with a bowl of Jell-O you took out of the fridge just moments before! Yeah. Wipe it up as soon as it happens! Be kind to yourself!

According to the National Floor Safety Institute:

Falls account for over 8 million hospital

emergency room visits, representing the leading cause of visits (21.3%)

Half of all accidental deaths in the home are caused by a fall. Most falls happen at ground level

rather than at an elevation.

22% of slips/falls results in more than 31 days away from work. (US Dept. of Labor 2002)

Fractures are the most serious consequences of falls and occur in 5% of all people who fall.

Those are some staggering numbers, if you ask me! I would encourage you to go to the web site at www.nfsi.org for more information on home safety as well as work safety. Knowledge is power and in this case, safety!

Would you join with me by making it a goal in 2017 to practice the same safety precautions at home that we hear about nearly weekly in our safety talks? You are just that important. Your family will thank you too.

It Was The Best of Times, It Was The Worst of Times

"It was the best of times, it was the worst of times..." (Charles Dickens, <u>A Tale of Two Cities</u>). This Christmas was definitely from the Dickens novel. The opportunity to celebrate the holidays with family and have a few days off was the best. But the volume of parcels was overwhelming to say the least. We had rural carriers working 60, 70, 80, and 90 hours on a weekly basis. Exhaustion, long hours working in the dark, and multiple trips all made for a difficult holiday delivery season, yet rural carriers definitely delivered for our customers. We all have the right to feel proud of our accomplishment of delivering loads of holiday cheer.

Late last November, we were told that there would not be another Memorandum of Understanding that would allow Regular Rural Carriers to work on Sundays. It wasn't much later that the Postal Service was pleading for a MOU covering December 4th,

11th, and the 18th that would allow Regular Carriers to volunteer to deliver parcels on those days. Headquarters Delivery Operations began their plea with "... due to an unprecedented

volume of parcels" and then we saw the parcels, and they are still coming. I think that we all recognize that the parcel level is still above whenever we all last counted. This is making it very difficult for rural carrier to make evaluation. It is my hope that we will all remember that we must work in a safe and diligent manner. Please note that "SAFE" comes FIRST. We must not allow pressure to put us in the position of making a choice between two bad options.

Normally right after the holiday season, we would be gearing up for a National Mail Count in February. With the negotiated contract that was ratified by our members this last April, we do not have a count. The first opportunity to count is the last 12 working days in September, and only if the Postal Service opts every route nationwide to be counted. The Postal Service did that in 2011 and 2012. In each case, the overall route evaluations went up.

There is some good news. The Rural Time Study is still moving forward and soon individual rural carriers are going to have the opportunity to directly participate. First will be those offices that have been involved in the delivery portion of the time study. We are in the process of putting rural routes on the Rural Delivery Database. Each route is going to be mapped on a computer database. The carrier will show where the mailboxes are, where they would generally drive to if they had a parcel they had to take to the house, and where the door is to the house where they would deliver the parcel. Hopefully with this data, we will be getting a more equitable time standard for all these parcels we are delivering.

So, what do we need to do in order to prepare for the Rural Data Base?

We need to make sure that our PS 4003 is up to date. We need to make sure that the turn-by-turn di-

rections are absolutely correct. When we are getting ready to put a route on the database, we collect 30 days of "bread crumbs". The bread crumbs are created every second by the

"pinging" of our scanner. After the 30 days, the computer is able to show generally where we are actually travelling in delivering our route. If we are off of our line of travel, it will show up and cause problems.

The PS 4003 needs to be updated for another important reason. Each time the PS 4003 is submitted, the top part which has our mileage, boxes, parcel lockers, and collection compartments may need to be updated. If we are delivering to 18 or so regular boxes and they are not included in our box count, then we are likely being compensated an hour less than we should. If you look at the PS 4241-A from the last time you counted, you can find your box count from that time. At the bottom, it will tell you if you have a "bank". The "bank" shows in time how much you have accumulated to your next evaluated hour. Please remember that each evaluated hour can mean a difference of \$1,100.00 to \$2,100.00 per year, de-

pending on your Step.

The edit book needs to be gone over line by line to make sure that each and every box is accounted for. We need to verify if it is an active box or vacant. We also need to verify that the boxes are in the correct order. If the boxes are out of order, that will create a problem with the Rural Data Base when we are trying to place mailboxes. Also, boxes out of order create errors in our DPS.

We need to make sure that when we make our first scan of parcels is where we are actually delivering the parcel. The GPS location is determined where we initiate that first scan, and **hopefully** when the evaluations from the time study come in, we will be compensated the time it takes to go up a driveway and dismount to take the parcel to the door. But if the GPS location only shows us in the vehicle at the mailbox, there will be no credit for the extra work.

Finally, the weather these past few weeks in the

Portland District has been challenging, to say the least. Our District Manager, Tyrone Williams, has repeatedly stated that our safety comes first. It is critical to remember that if a situation looks unsafe, that we should not go there. The reason we work is so that we may enjoy a certain lifestyle. If we get hurt, sometimes those injuries may last a lifetime. With all that we have to do, it is sometimes easy to get stressed, but we have to think of keeping ourselves safe first.

I am appreciative of each and every Union member. I hope that every rural carrier is or becomes a member of this Association, and each member becomes actively involved.

Remember: Ignorance may be bliss, but ignorance will cost you!



Your Union Needs You!

Your Union needs YOU! In every office with rural delivery, there exists one person, and quite often there is more than one, who has the skills, drive, and determination necessary to serve as the local steward. You may be just starting in your USPS career, or you may be a tenured carrier looking to spread your wings and become more involved in the rural craft. In either case, your local office and your Union needs you. Exciting challenges and opportunities await you as local steward; now is the time to take that step.

From the NRLCA Constitution, Article IX Section 7.B.1, (emphasis added) "Any member in a local office or a delivery unit may be elected Local Steward and shall serve until a successor is elected and certified or until he/she resigns. Where a local steward is in place, any member may call for an election in the month of July of every fourth year. An election may also be called for any time the position is vacant, or when two-thirds of the members submit a petition to the District Representative for approval."

Local stewards receive training prior to being cer-

tified as a local steward and, once certified, you will have direct contact with an assigned NRLCA representative who will serve as your advisor; who will lead you step-by-step through the grievance procedure. You need not worry about "not knowing what you're doing" because not only will you have the local steward certification training to get you started, but also direct contact with an NRLCA representative for any questions you may have.

As local steward, you will be compensated by the Postal Service for time spent in grievance handling, including the time necessary for investigation and meetings with management. You will also be compensated by the Postal Service for the time necessary to write a grievance. When we have a local steward in place in a given office, the Postal Service bears the financial burden at Step 1 for any grievances that arise in that office. Without a local steward, the financial burden is borne by the Association.

The process of becoming a local steward is quite simple. A form calling for the election of a local stew-

ard is posted in your office for a minimum of 15 days. During this 15-day period, any Union member can place their name on the form indicating their desire to be considered for the position. At the end of the 15-day period, at the time and place identified on the form, an election is held and the person receiving the majority of votes cast is elected as the local steward. You will then be scheduled for the local steward certification training. The steward election form (Form 10) is available on the NRLCA website. Once you

have logged on to NRLCA.org, navigate to "Steward Operations", click on "References" and then "NRLCA Forms" and select "Form 10." You can also obtain a Form 10 by contacting me at patrick.pitts@nrlca.org, or (360) 893-9182 (office) or (509) 280-7444 (cell).

Now is the time. Feel free to contact me with any questions you may have. I look forward to welcoming you to the steward-ranks of the National Rural Letter Carriers' Association.

Duties and Responsibilities of Region Committeepersons (Executive Committeemen)

From WARLCA Constitution ARTICLE V

Officers and Appointees

D. Executive Committee

The Executive Committee, or a majority of them, shall act as Trustees of the WARLCA, and in conjunction with the President, have general supervision and control of the WARLCA.

It shall be the duty of the Executive Committee members to aid in keeping carriers in their particular Regions interested in WARLCA work and in keeping up the membership of their Regions. They shall perform such other duties as the WARLCA may, from time to time, direct.

Our History in Book Form

Many of you may have wondered what mail delivery was like in the early days of Washington State, and who were those hardy souls who ventured out into the rural areas to deliver the mail back before there were paved roads and even automobiles. Look at the NRLCA logo. That's how we started.


Recently, I ran across the name of Guy Reed Ramsey, the author of a series of books titled Postmarked Washington. Mr. Reed was a travelling salesman, originally from Iowa, who had moved to Washington State in 1944 to sell wood preservative products to farmers and ranchers. He was fascinated with mail delivery in his home state, having even written a book about early post offices in Iowa, so it was only natural for him to collect information and stories about the origins of mail delivery as he visited the small communities around our State. Most of the small towns, especially in eastern Washington, were centered around the Post Office, and often the Post Office was located in

the general store. When Mr. Ramsey visited these towns, he would go to the Post Office and gather as much information as he could. He would talk to the locals, many of whom had fathers and grandfathers (and even mothers and grandmothers) who had worked for the Postal Service in "the old days". When he retired in 1960, Mr. Ramsey began to put together all of this information and the stories he All photos this page are excerpts from Postform. The result was an


INTRODUCTION

Mail came to the Northwest country long before there were post offices. Letters travelled back east from many who ventured to this land when it was known as a wilderness. Yet there were no official Travellers over the westward trails were entrusted at the start of their journey with missives addressed to loved ones who preceded them on the pioneer venture...to fathers, mothers, brothers, sisters, sons, daughters, perhaps to husbands and friends. Letters were satisfies, soms, dauginers, perhaps to insurance and friends. Letters were tucked into leather packets of trappers as they departed for another season on their traplines. Some such letters were written in the conduct of the fur business, others were strictly personal and were delivered whenever and wherever the unofficial mail carrier met the addressee. Military mail also followed the early trails bearing orders from Washington to remote posts or Indian agents. Military scouts often carried letters of an unofficial nature. Missionaries reported to their eastern headquarters and headquarters sent letters back to those who had gone west to carry the word of God to the tribes of the Pacific Northwest. Letters accompanied those who covered the long distances afoot, by horseback, by horse or oxen-drawn wagons, and by canoes. The earliest letters bore no stamps, were struck with no postmark, nor were they entrusted to any official mail service. Yet they arrived eventually at destination unless fate in the form of a band of Indians, starvation, flood, fire or storm interfered. Later as the trails became more defined and freighting became a business, the freight and express companies took letters to and from the Northwest. Usually such letters bore the name of the express companies as a postmark. These covers, as they come to light from time to time are collectors items bringing lively bidding between those who seek to add


