2025 Convention in Orlando

A View from the State President

What a difference a year—and a committee position—makes! The 119th annual National Rural Letter Carriers' Convention was held August 19–22, 2025, but for me it began much earlier thanks to an unexpected committee assignment. I arrived in Orlando on August 13 and started work with the Resolutions Committee the very next day.

To say it was an eye-opening experience would be an understatement. Our five-member committee met daily from 8 a.m. until after 7 p.m., reviewing 460 resolutions. Our task was to identify duplicates, remove those already passed, redirect items that belonged to the Constitution Committee, and determine which were binding. It was tedious but meaningful work, and I was honored to serve. Unlike last year's committee, we finished by Monday afternoon, giving me just enough time to attend part of the State of the Union meeting before hurrying to the Lady Carriers' Club. From there, it was straight into Flag Ceremony rehearsal - where I had to gently remind the presenter that I was from Washington, not Wisconsin! - and finally on to the Rally at City Hall.

Despite stormy skies, the rally went forward. This was my fourth anti-privatization rally (and third this year), and the energy from the crowd was contagious. We heard from union leaders, representatives of other crafts, two local members of Congress, and our own Michael Gan, whose voice and passion continue to inspire.

Day One - Parade of States The convention officially opened with the Parade of States, and as WARLCA President it was again my privilege to carry the Washington State flag. Our delegation this year included all 21 elected delegates and one alternate. Our two first-time delegates, Al Cortez and Sherry Cortez, represented our state admirably. Jeff Taylor proudly carried the Marine Corps flag, and we were delighted that David Hamilton and his

wife Valerie (our Auxiliary Secretary-Treasurer) were in attendance for the HERO Award ceremony.

Washington shined again during the awards presentations: we earned top honors in both PAC categories, received an Honorable Mention for our state publication, and celebrated Isa Lopez as **Outstanding Member of the Year**. Please take time to congratulate PAC Chair Christiana Lee, Editor Lisa Levitt, and Isa Lopez when you see them!

Day Two - HERO Award & Nominations Wednesday brought one of the highlights of the week—cheering on our HERO of the West-Pac area, David Hamilton. To our joy (and his surprise), he was selected as the Overall Winner of the HERO Award. Later that morning, nominations for national officers took place. As campaign manager, it was my honor to nominate Patrick Pitts for Vice President of the NRLCA. The afternoon was spent voting on Constitution changes. The evening's banquet provided great food, fellowship and dancing as much of the Washington delegation

spent time on the dance floor!

Dav Three Resolutions & Caucus Night began Thursday with my committee on-stage presenting resolutions. I can now say I know far more about process than I ever imagined - and hope to use that knowledge to help our members craft future resolutions. That evening was

WA State Showcased in FL

It's not often the Washington Rural Letter Carriers' Association outshines the other states at the NRLCA national convention, but this year was different. Patrick Pitts was reelected for another year as your national Vice President. While Patrick works for all members, it's advantageous to have one of our own at the national level. We look forward to hearing his words of wisdom and the direction of the craft in the future.

David Hamilton brought down the house (so to speak) when he was presented

with the WesPac Hero of the Year / award in Orlando at the 2025 National

Convention. Of the four regional Heros

of the Year, David had a well thought out and well delivered thank you speech to the national delegates. It was more than a quick thank you but a humble account of how he saved and shielded an elderly customer and her dog from an aggressive dog.

The judges were Jenna Goldstein, MSN, CRNP, PNP-PC, a nurse practitioner with the Emergency Department at Children's Hospital of Philadelphia; Charlie Salazar, Fire Chief at the City of Orlando Fire Department; and Dr.

Terry Flander, a family medicine physician in Scottsdale, AZ with over 35 years of experience in the medical field.

WesPac Area and Overall Hero of the Year: David Hamilton, WA. Rural carrier David Hamilton came to the aid of a woman and her small dog who had been attacked by a larger dog. The woman had already fallen, injuring her arm, and was helpless against the powerful animal. As time was running out, David hurled an empty tub at the attacking dog and continued to fight it off with his ice scrapper. He helped her into the back of his mail truck to keep her safe until neighbors and police arrived.

To everyone's surprise, especially David's, he was chosen overall as the NRLCA National Hero of the year by the

judges. While David did have a prepared speech for his WesPac Hero of the Year, he had no idea of the overall award bestowed upon him. David rose to the challenge and thanked everyone for their vote of confidence in him and gave credit to the neighbors who assisted him during the aggressive dog incident. He went on to tell the national delegation that being awarded National Hero of the Year was the second-best thing to happen to him. What many others and I did not know is that David is

actually a Canadian citizen. But in May he had applied for his US citizenship. As David put it, the day he receives his US citizenship will be the greatest honor bestowed upon him.

The WARLCA is proud to have David in our ranks. His dedication to the craft and his customers exemplifies rural carrier service and dedication. Well done, David, well done indeed.

Lastly, on the legislative front.

On July 16, Rep. Dan Newhouse (R-WA) became the 218th co-sponsor of H. Res. 70, giving the resolution a majority of members

who feel the House "should take all appropriate measures to ensure that the United States Postal Service remains an independent establishment of the Federal Government and is not subject to privatization." Currently, the total number of cosponsors stands at 221.

While we all must remain vigilant of those who wish to privatize the postal service as of today our combined effort has sent a strong message that the US Mail is NOT for sale.

Stay safe and look out for each other.

Famous Letter Carriers

This issue will depart from the history of unions and look at some of the more notable mail carriers over the years. In no way is this an exhaustive list but what I have found doing research over the years.

Postman

Enterprises attending mail equipment sales cultivate talented work forces. Ensuring the timely delivery of letters and packages often requires both ingenuity and determination. Quite a few famous figures in the United States have worked to help process and deliver mail, for example.

Politicians

Benjamin Franklin, Abraham Lincoln, Harry Truman, and Adlai Stevenson all at one time served as Postmasters or Assistant Postmasters. When future President received a Congressional Truman appointment as the Postmaster Grandview, Missouri in 1914, he reportedly turned over the position (and the \$530 annual salary that went along with the office) to the impoverished widow of a Civil War veteran. Ella Hall managed the Grandview post office for him.

<u>Celebrities</u>

Celebrities have sometimes worked in mail delivery, too. Typically, they filled jobs in mailrooms before gaining fame. Just consider some well-known individuals who worked in this field:

Bing Crosby (1903-1977) The late singer and actor Bing Crosby worked briefly as a substitute and regular postal clerk. He helped customers mail letters in Spokane, Washington in 1921.

Conrad Hilton, Sr. (1887-1979) Before he became a millionaire, 23-year old future hotel magnate Conrad Hilton served as the Postmaster of his home town of San Antonio, New Mexico. He held this position between 1910 and 1911.

Sherman Hemsley (1938-2012) The star of The Jeffersons and Amen spent several years working in mailrooms in Philadelphia and New York City during the 1960s. He used his position as a postal clerk to support himself while he auditioned for roles on Broadway early in his acting career.

Charles Lindbergh (1902-1974) The

daring aviator Charles Lindbergh successfully won a contract to deliver air mail for the U.S. government between Chicago and St. Louis during 1926 and 1927. He flew a de Haviland DH-4 (a biplane day bomber from the WWI Era) along the air route, with stops at airfields in Springfield and Peoria.

John Prine (1946-2020) Between 1964 and 1969, singer and songwriter John Prine worked as a letter carrier in Maywood, Illinois.

Walt Disney (1901-1966) During 1918 and 1919, the man who would later help bring a host of beloved animated characters to movie screens found employment as a substitute letter carrier in Chicago and a temporary Christmas mailroom worker in Kansas City.

And lastly, I'd be remiss if I didn't mention man's best friend...

At first, Owney stayed close to the Post Office, but he soon began riding mail wagons to the train depot and the railway mail car down to New York City and back to Albany. As Owney traveled farther, his friends at the Albany Post Office feared he might wander too far away to find his way home again, so they purchased a leather

collar with a tag reading "Owney, Post Office, Albany, N.Y." Railway mail clerks recorded Owney's travels by attaching metal baggage tags to his collar to identify the rail lines he traveled on. He was soon so weighed down by his collection of tags that Postmaster General John Wanamaker presented Owney with a jacket to distribute their weight more evenly.

Owney took to traveling farther and staying away longer, eventually visiting Mexico, Canada, Japan, China, Singapore, Suez, Algiers and the Azores.

One day, while being shown off to an Ohio newspaper reporter, Owney bit the clerk who was handling him. The postmaster had Owney put down on June 11, 1897. Railway mail clerks chipped in money to have a taxidermist preserve Owney's body, which then was sent to postal headquarters in Washington, DC, for exhibit. In 1911, the Post Office Department entrusted Owney to the Smithsonian Institution. Since 1993, Owney has been on display at the National Postal Museum in Washington, DC. In 2011, Owney was honored on a commemorative U.S. postage stamp.



Round and round we go. Open season is upon us and there is nothing you need to do if you wish to stay with your current insurance provider. For members of the National Rural Letter Carriers' Association, NRLCA, I want to let you know that there is a unique insurance plan just for Rural Carriers, annuitants, and their families: therapy coverage; wellness massage incentives for members over 18; \$20 co-pays for in-network primary care provider office visits; 100% coverage for in-network cancer treatments, preventive care, and maternity care. To find more details of this program visit the **OPM.gov** website.

Qualifying Life Event, QLE. The more common events are the birth or adoption of a child and marriage. For complete details of *ALL* QLE visit opm.gov for more details.

Will you be making changes this open season? Be sure you register with the Postal Service Health Benefits Program (https://health-benefits.opm.gov/). This took me several minutes to do because, if this is your first time you will need your driver's



license, state ID, or passport. It will also ask for your social security number and phone number. Yes, you will need a two-step authenticator as well to log in. I did it and it was painless but if you prefer not to submit it online, you have the option to mail it in. Given the time limit, it may take longer than you wish. Remember Open Season is from **November 10- December 8, 2025.** You

can also call the Human Resources Shared Service Center 877-477-3273.

Plan to spend some time on the

computer if you are not familiar with any of the websites. Do not wait until the last minute when making any changes to your benefits. Get online do your research. Ask questions. And most importantly please have all your login information, details, credentials, whatever up to date ahead of time.

Signing up for Withholding

Adjustments & Frozen Routes

There have been multiple questions concerning carrier's rights during route adjustments under Rural Route Evaluation Compensation System (RRECS). Article 30.1.J states; "the regular rural carrier assigned to the route shall be notified in advance of any route adjustments and afforded the opportunity to submit comments in writing. The comments will be

considered as a factor when such adjustments are u n d e r consideration and before any decision is made".

When the route is frozen and there is growth, ... a carrier must keep track of the new deliveries

When providing written comments for consideration, one must articulate information such as what routes you and another route's travel is on the same streets, which part of that route you could pick up and service, or which portion of your route could be used for the other route; don't simply say I don't want to be adjusted. You can, however, state "I want it to be reduced to 45K due to the loss of Amazon deliveries in July 2025" or something to that effect. We all know that management gives little to no concern about our written requests, but in the event there is an issue, the carrier input is looked at and utilized, and questions are asked why management didn't do this or that.

Once management has completed the interims, you should be given a copy of the interim to review and there is also a place to sign that you reviewed it. It is important that you review the information for your adjustment. I understand that the form is hard to follow and seems complex, but you can verify the information if you take the time to do so.

Look at everything; does your route have the correct boxes listed and other accurate information on the top lines of each

sheet? These are the starting numbers of your route's current route data; do they all match the information on your current PS Form 4241A? If your route is overburdened, look at the items being removed from your route and the totals on the bottom of each Excel for what management is saying should be your final numbers. questions if you have any, now is the time to make changes if any are needed before the adjustment goes into effect. Find out did they physically drive the new line of travel to obtain the mileage on the route. If management cut and paste the mileage, request an official route remeasurement or demand they utilize accurate miles as indicated in management's training. Did

they count the actual traffic control points (TCP)?

Below is the side section on the adjustment program so you can review your information accurately using the route's PS Form 4241A and 4241M. Please ensure that management is doing all things necessary

to make an accurate interim adjustment, this is your pay, and management should be placing high importance on making sure it is accurate, utilizing the training given to them. Route adjustments shouldn't be pencil whipped to be completed.

Once your route has been adjusted, it will be frozen for 52 weeks or more, depending on when your route was adjusted and when the next Mini Mail Survey (MMS) occurs. When the route is

frozen and there is growth, new deliveries being activated, a carrier must keep track of the new deliveries. Knowing if the route has gained 60 minutes in evaluation is harder than in past. Once you believe you have enough growth to add 60 minutes and increase your route evaluation, give your higher-level steward a call. We will run a program to determine if you need to file a grievance for the increase to be implemented. We will need you to send us a copy of your interim from your adjustment and the total number of boxes added. Please make sure you track regular boxes added and central boxes added, they receive different time standards to assist us in making the calculations.

It is important to remember to continue completing your hotkey entries and all other duties to continue to ensure your 52 weeks of data is correct for your next MMS and new route evaluation. Once your route is unfrozen, the evaluation of the route will go into effect upon completion and

implementation of that MMS.

website is NRLCA The woefully underutilized by many carriers. Educate yourself on all things involving RRECS, it is your responsibility to ensure that you are properly compensated for your route. We more control over our route evaluations than we have for the 31 years I have worked for the USPS. Make the investment in yourself and learn what you need to do to get all the credit the route deserves.

Knowledge is power, ignorance is not bliss. Don't cheat yourself!

Darline Kendall, 50-Year Membership Award

Darline Kendall was born into a rural carrier family, and she learned early on that women did not have to accept society's predetermined roles. Her mother's sister, Mae, was married to a rural carrier who died at a young age. Mae, who was 25 years old at the time with a 5-month-old son, applied for the vacant position. She scored higher on the test than the 43 male applicants for the position, was hired, and served for 30 years.

Darline started carrying mail at the age of 40 as a sub on a contract route in Pasco, but it wasn't long before she realized she should apply for a rural carrier position. Darline told me that, as a single mother at the time, being a rural carrier was one of the very few jobs a woman could hold that paid the same as a man. When the Richland post office requested help from the Pasco office, Darline was the one they sent. She stayed on, first subbing on a regular route and carrying an auxiliary route as the first female carrier in the office, and then eventually going regular. She faced a great deal of criticism from the male city carriers, who felt the route should have been given to one of them. What was worse in her

mind, though, was when she attended her first WARLCA state convention. The male delegates were shocked and surprised that she was there as a delegate, and a member

of the Auxiliary, upon learning Darline was actually a rural carrier and not the wife of a carrier, stated from the

Thank you for being a trailblazer for all of the women rural carriers who have come after you

podium that Darline "had no business working on a man's job" and that "if this continues, we soon won't have an Auxiliary". Darline also caused a stir when she wrote a letter to the editor of the Washington Rural Postman questioning why her daughter was seemingly ineligible for an Auxiliary scholarship, simply because Darline was single.

Being the independent woman she is, one of her earliest mail delivery vehicles was a bright red Dodge Dart, which many of her customers thought looked like the Starsky and Hutch car, and on which she put personalized license plates reading "FEMAIL". During the snowy winters in Richland, she regularly carried two chained -up wheels in her delivery vehicle, and when needed, she would pull into a driveway and change the wheels. She also writing to Readers remembers Digest, complaining about how the magazine jackets would catch on to other mail, and not long after, seeing them changed to plastic covers.

carrier and currently lives in Arizona. She told me she would love to hear from other retired rural carriers. Her


