

those who are serving as Committee Chairpersons for the various 2010 National Convention committees are encouraged to attend.

Sunday, June 21, 2009 will also feature our **Sunday Social** at Riverfront Park from 6:00 - 7:30 p.m. Make plans to attend for **Food and Fun in the Park**.

The official 2009 State Convention begins at 8:30 a.m. on Monday, June 22, 2009. **Jeanette Dwyer, Vice President of the National Rural Letter Carriers' Association** will be joining us during our convention. For those of you who have not had the privilege of hearing Jeanette speak this will be an amazing opportunity that is not to be missed.

There will be a meeting on Monday, June 22, at 8:00 a.m. for those who are attending a State Convention for the 1<sup>st</sup> time. At this meeting you will learn what to expect during the business sessions of the State Convention, how to participate, and you will have an opportunity to ask any questions you may have about the convention.

Monday evening will feature training (with dinner) for all newly elected County Unit Officers. The dinner begins at 6:00 p.m. with the training commencing immediately following dinner. All newly elected County officers are encouraged to attend.

Tuesday evening will be filled with food, fun and laughter at the annual Convention Banquet. The banquet will be held at the Rockin' B Ranch. Come join rural carriers from across the state at this amazing, fun event.

The deadline for convention registration is May 31, 2009. There is a late fee of \$20.00 if the registration is not received by the State Secretary-Treasurer by May 31, 2009 so register early. The deadline for hotel reservations is May 20, 2009. For room reservations call 1-800-RED-LION (1-800-733-5466) and ask for the WARLCA rate.

## **E-Career Hiring Process**Cheri Freeman, State Vice President

E-Careers is the new process for hiring all new Postal Employees, including RCA's and TRC's. If you have a TRC in your office that wants to convert to an RCA and has taken the old test, passed, and think they



are on the Register and can be converted as soon as there is a relief vacancy, they need to be informed of the new E-Career process. The old registers were discontinued as of February 14, 2009. Postmasters and appropriate district personnel are responsible to make sure all vacancies are posted in the E-Career system.

Vacancies are posted on the USPS.com Website for two weeks so applicants need to keep checking for the postings at least once a week in order to apply within the deadline. Applicants must register and complete an online application. Once they have an E-Career profile they can apply for job openings anywhere in the Postal Service as well as any location in the United States.

To find a job posting as a Relief Carrier, the applicant must LOGIN to USPS.com and go to the bottom of the page and click on: career; Job Search; Job Title (ex. rural career); Location (you can type in city or put in state and all postings state wide will be listed); Functional Area (for TRC or RCA, click on Customer Service/Delivery); START. The job posting will list the job posting # at the top of the page, and all job descriptions and information is listed below. You can now click on Apply and follow the instructions provided. A test will be administrated by an outside test service company and will cover all positions for the Postal Service, not just the carrier craft.

The biggest glitch in the E-Career process is getting the vacancies posted in the first place. If

you know of a vacancy that is not being posted, contact your management and ask if all the Form 50's have been cut to take all former employees off the roles so the vacancy will appear in the office. In addition, management needs to submit a hiring request for the vacancy. Remember, all routes still have the right to have a relief carrier assigned to their route.

## State Secretary – Treasurer's Report Becky Wendlandt

I guess I am one of the lucky carriers (yes lucky, because the mail count is the same as throwing dice in Vegas). My new route only went down 2 hours compared to my previous route going



down 4 hours. Even scarier than that is that last year I said I was one of the lucky ones because my route only went down 3 hours. That's a total of 5 hours less pay in 2 years! True, I had a few less parcels, a few less flats, a few less letters and a little more DPS. True, I had lots less markups by going to the bundle system, and just as many address changes but thanks to PARS they are worth very little - even though catching those individual forwards takes the same time. So some would say it was accurate going down based on that information. However, the **truth** is what was once considered a parcel is now a flat, what was once considered a flat is now a letter. While once a majority of parcels fit in a mail box they are now too big and have to be taken to the door. So I am doing what all of us are doing, pushing myself to keep going; having heavy volume days that make you wonder if all the mail was processed on one day, then light days that I think the plant did not run mail at all. BUT I still end up opening each NDCBU, stopping at almost every box for 2 letters or 10 letters depending on the day, and wearing out myself (and the POV). Anyone else out there want to go hourly? Way to go Postal Service! You have taken my 2 hours to give to the PMG who

got another raise and bonus, and to keep paying those big wages to pencil pushers who don't see us as team members but robots to do their latest and greatest ideas of the week.

Anyone else think that delivering sale catalogs when they arrive and not when the mailer requests them to be delivered is just plain stupid and only makes the mailer and customer mad? Just another idea of the week that is killing our business! Why do the workers take the cuts and hits and the top management get increases based on a business they say is in the red? Does anyone up there on the top have ANY common sense?

What Can We Do? It is not too early to be thinking about what **resolutions** you would like to present at your upcoming county meeting. Your County Secretary will have the form at the meeting, but bring your ideas in writing so that it can be discussed and voted on. This is the grass roots of how you get your thoughts and concerns to be discussed and voted on at National Convention. If it is important to you, it probably is important to other members too, but somebody has to start the process by submitting the resolution. Why not YOU? NRLCA starts contract negotiations next year, so it is time to let our National Officers know what we want, what is happening on our routes, what we need to survive to retirement. Keep in mind, National Convention will be in Spokane in 2010 so what a perfect time to come to convention and vote on what is important to you!

**State Convention:** WHAT IS YOUR VOTE WORTH? <u>Priceless</u> - the same as each and every one of your fellow county members, board members, and stewards! ALL county credentialed delegates get paid the same rate for mileage and the same convention allowance, no matter if you are a relief carrier (RCA), regular carrier, or retired carrier

Here are your duties as a credentialed county delegate to State Convention:

- Specific assignments to a committee as notified by the State President.
- ➤ Be in attendance at all business sessions of the State Convention beginning with the

opening session and not leaving until the Convention has been adjourned.

So, if you can attend all 3 days of State Convention, then make sure you attend your county meeting and ask to have your name on the ballot for State Convention delegate to the 2009 State Convention in Spokane, WA!

National Convention Delegates: The National Convention delegate nomination form will be in the February issue through the May issue of the National paper. All you need to have your name on the ballot is to complete this nomination form and mail it to the State Secretary. I will acknowledge the receipt of your nomination form with a returned letter. If you have not gotten a return letter from me 4 days after you sent me your nomination form, please call (509) 710 7840 to verify that I received it. Otherwise your name might not be on the ballot.

## MARCH 23-25, 2009 MINUTES OVERVIEW FROM WARLCA BOARD MEETING Doubletree Southcenter, Seattle, WA

MEMBERS IN ATTENDANCE: Patrick Pitts, President; Cheri Freeman, Vice-President; Becky Wendlandt, Secretary/Treasurer; Susie Hill, Editor; Becky Pike, District One; Renee' Cowan, District Two; Cindy Koker, District Three; Ed Ogdon, District Four; Dan Schrup, Retired Rep; and Joyce Patteson, State Steward. President Patrick called the meeting to order at 8:30 AM on March 23, 2009. After a brief positive go around, we reviewed the agenda. Patrick had provided each board member a packet of information that can also be used at county meetings. Susie reported that \$485.20 was collected for PAC at the District One meeting.

#### **Minutes:**

The minutes from the October 5-8, 2008 Meeting in Silverdale, WA were read and corrected concerning enhancement training. Tasks were reviewed and those not completed were left on the task list.

## **Board Policy and Tasks Reports:**

The board policy was reviewed and updated. Tasks from the last board meeting were reviewed.

## **National Trainings/Meetings/Seminars:**

- Patrick and Becky reported on the new State President and State Secretary/ Treasurer seminar in DC in September, 2008. Lots of information was brought back.
- Susie, Cheri, Becky P and Becky W reported on the National Convention Host States Meeting in November, 2008. They came back with new guidelines and rules.
- Patrick, Joyce, Renee', and Cheri reported on the Regional Steward
   Training in Las Vegas in November,
   2008. Patrick took 20 pages of excellent notes. They were disappointed that all the information and handouts were not scanned in and burned on a searchable CD.
- Becky reported on the National Convention Chart of Accounts Committee she attended in February, 2009. Our 2010 National Convention books have been updated to reflect the new chart of accounts.
- Cheri reported on the Assistant State
   Steward Training that she and Monte
   attended in DC in March, 2009. National
   notified Patrick that both had passed.
   Patrick and Renee' will need to attend the
   next training available.
- Becky will be attending the National Area Secretary-Treasurers Seminar will be April 1-2, 2009 in Phoenix AZ.
- Joyce will be attending the State Stewards Seminar April 14-16, 2009 in DC.
- Becky and Charles will be attending the National Convention Media Committee meeting in DC on May 12-14, 2009.

 Patrick and Cheri will be attending the 2009 Presidents' Legislative Seminar on Capitol Hill in DC on May 17-20, 2009.

## **State Steward Report:**

<u>District Updates</u>: Joyce reported that Spokane District is one of the six districts that will be closed. Eastern Washington will now be in Seattle District. Also, the position for workplace environment has been eliminated in the USPS. Washington State will now be under two districts, Seattle and Portland.

Grievance Activity: Joyce said she has appealed 9 Step 3's, 6 of them from the last board meeting. One was disciplinary, all others contractual. Of the Step 3's that have been appealed, 3 were settled and 1 was denied which will go up to National.

Equipment and Software: Joyce said the Ricoh is not working properly and that she also needs Adobe Professional 9 for her laptop. The Brother-All-In-One Multifunctions are all getting older and will need replacing in the future.

Mail Count Training Update: Discussion that the mail count trainings this year were not as well attended as last year. All mail processing centers were inspected before and after mail count.

<u>Full-Time Assistant State Steward Position:</u> The board reviewed the ADOP/LWOP usage from 2008. The board decided that to avoid any more Assistants going over 130 days of LWOP for the year we will need to appoint one assistant full time for the Seattle area, where the majority of routes/carriers are located.

#### WRC:

The board discussed the last issue of the WRC for the 08/09 year:

## **State Secretary-Treasurer Report:**

Membership: Membership is at 1940, down from 1952 at the last board meeting. National has just sent out a booklet to non-member RCAs with information in it and a dues form. Becky will still be writing new hires every month, and plans to do a follow up mailing just before the RCAs get their increase in pay on November 21,

2009 for \$.26 more to \$18.50 per hour. Financial: The board reviewed the 8 month financial statement and budget for the rest of the year.

Consensus is to leave the 70% cap (which would be \$18,000) on 2009 State Convention delegate pay as of now. This will be reviewed at the meeting just before State Convention.

WARLCA Constitution: Becky sent the board the proposed changes to the WARLCA Constitution that were suggested by the National Constitution Revision Committee. Patricia, committee member, has reviewed the changes. They will be voted on at State Convention.

County Meetings: The following are the annual meeting dates for the county units:

All county meetings will have a state level steward in attendance as well as a board member.
Vouchers: The board reviewed 5 months of vouchers.

## **WARLCA Website:**

Patrick gave a presentation to the board on an example of a possible WARLCA website and links. WARLCA has purchased domain names of WARLCA.com, WARLCA.net, and WARLCA.org for 3 years for \$77.00. Discussion was held concerning the need for Adobe Dreamweaver software and finding a hosting site. Patrick has county and district maps, as well as links for membership.

State Convention for 2009 will be in Spokane at the Red Lion Inn at the Park on June 22, 23, 24, 2009 (Monday-Wednesday). Cindy is the Chair for 2009 State Convention. The board reviewed the program for 2009 State Convention

Discussion on having 2012 State Convention in Moses Lake or Wenatchee area, however bids will be taken for all of District Three area to be reviewed by the board.

## **National Marrow Donor Program**

A few months back a lady from the National Marrow Program came to the Pasco Post Office and asked the city and rural carriers to consider putting their name on a register for the National Marrow Donor Program,



NMDP. The NMDP maintains a registry of more than 7 million people ready to save a life by donating marrow to a patient in need. The Post Office supports the NMDP and will pay the cost of you signing up. All you have to do to register is fill out a simple form and swab the inside of your mouth. If they find that you are a good candidate to donate your marrow to someone they will ask you to have blood drawn to confirm you are a good match with this person. They would then ask you if you would like to proceed and if you did they would have to start preparing the patient for the procedure. From the time they think you match someone until you actually donate can take up to 2 months or more. When it is time to donate they will give you some drugs that will fool your body into making too much marrow. Five days later they hook you up to a machine to draw out your blood, centrifuge it, take out the marrow, then give you back the rest of your blood. They don't stick a long needle into your spine anymore and there is no recovery time needed for you. So if you think that this is something you might consider I urge you to talk with your Postmaster to set up a meeting in your Post Office with the NMDP. If your office is too small you can go to the NMDP web site at MARROW.ORG. Yes, I did sign up and I urge you to join me.

# Mail Count, Vacant Routes, and OWL/EI--Oh My!!

Another mail count has come and gone and most of us ARE worse for the wear. There are no hard and fast statistics available as of this writing, but it appears that most routes in Washington averaged between a 2 and 4 hour



evaluation loss per week. There are now more J and H routes than ever which can really become an issue in formula offices. My own route experienced an unofficial loss of 3 hours—going from a 45J/41K, to a 46H/42J placing me square in the middle of that average.

It appears that this mail count—although detrimental to most of our evaluations, was less contentious in most cases than mail counts in the past. At least for some of us, that softened the blow somewhat of our falling evaluation. For those of you that didn't sign your 4241x as being correct, there may be a glimmer of hope. I am pleased to announce that a representative from Operations Programs Support and a state-level steward in both Seattle and Spokane Districts have agreed to meet to attempt resolution of some of your disputed items. Hopefully by the time you read this, you will have been notified whether or not there was any resolution of your issue(s). Regardless of whether any or all of your issues were resolved, it is still good news because the Sr. Assistant State Stewards and I have been working extremely hard to rebuild a mutually respectful line of communication between district management and the state association. Where there is communication, there is a better opportunity to resolve issues when they happen. I remain cautiously optimistic that hope is still a reality.

If there's a vacant regular route in your office, it's likely being held for potential rebuild of the

routes most negatively impacted by the mail count. If this is the case in your office, there are several things of which you need to be aware. First, you need to be aware of the contractual issues at play. Management has 30 days in which to post a vacant route. They may have an extra 60 days if an adjustment or consolidation is being considered in the area. This gives them a total of 90 days from the date the route becomes vacant to get the adjustment and/or consolidation completed and effective. If it's not completed within that 90-day time frame, the contract has been violated. Understand that where necessary, and where we were notified of the vacancy, we have initiated and/or processed grievances where this violation has occurred as the route should have been posted.

Second, don't forget that you have the right to give written input about the adjustment if your route is being affected. Management has no obligation to follow your suggestions, but they do have an obligation to consider them. Make certain you keep a copy of the written input provided as it can be used as documentation in the grievance process at a later date if the route adjustment turns out to be something other than practical.

Third, make sure your route has an official remeasurement using the proposed line of travel prior to the adjustment taking affect. There have been many times when routes were adjusted utilizing previous mileage data of the territory in question. Later when the route was remeasured, it was found that the mileage data used was not correct and the evaluation of your route after the adjustment has been incorrect due to inaccurate mileage information.

You may or may not have heard that by mid-August, all carriers currently under the umbrella of the Spokane District will be part of the Seattle District. The Spokane District is one of six districts nationwide that are being consolidated due to a multitude of economic reasons—one of which is the continuing decline of volume. Most of the Spokane District will join Seattle, with the territory in southern Idaho going to the Salt Lake District.

This, coupled with a reduction in management staffing, will bring even more changes to our job as we know it. Be prepared to be even more diligent in making certain your rights are not violated while understanding that you may need to have a little more patience, tolerance, and understanding when it comes to our workplace relationships with our fellow employees. "The times they are a-changin'," wrote Bob Dylan in 1963, and believe me, they are changin' hard and fast. Don't get left behind, and make certain that you're performing your job to the best of your ability.

The title of this article alludes to the possibility that I was going to write about the QWL/EI process. Since this has been the first opportunity to address you since its demise, I intended to share my thoughts as a former member of the Western Area Joint Steering Committee. Since my Oregon friend, fellow State Steward, and fellow WAJSC member, Roy Hamilton has already articulated his thoughts, I will instead present those as his article says it all.

## Why We Had No Choice

As a member of the Western Area Joint Steering Committee (WAJSC); the committee that became a major factor in the demise of QWL, I want you to know why it died.

First; the WAJSC mission was to "oversee, guide, and support the QWL/EI Process at the area and district levels. In particular, the AJSCs play key roles in encouraging management support of, and participation in, the Process and in ensuring that the DJSCs they oversee are active and successful."

When Bill Gordon appointed me to the eight member group in August of 2005, the committee "melded" immediately. We, and the three new management personnel, got along extremely well and spent time with each other even in the evenings after our meetings. That lasted about two years. Then Western Area began to micro manage the

managers. Money became their only focus.

The management members began putting a great deal of pressure on us to make a lot of changes, some of them drastic. We agreed to many of the less damaging changes. The WAJSC held annual "forums" comprised of all of the District Joint Steering Committee (DJSC) members one year and just the Co-chairs on the alternate year. Instead of that, we agreed to meet only with the Co-chairs of each of the committees each year. In the interest of saving the USPS money, we agreed to try it for a year or two. But that wasn't enough.

We nearly always held DJSC reviews with two DJSCs during the same trip in order to save money on travel. One time, we met with three DJSCs on the same trip. Whenever possible, we planned our meetings in cities where management members were already scheduled for one of their own meetings. We planned so that we would be reviewing two DJSCs in approximately the same geographic area and, sometimes, we drove from one location to the other rather than fly, in order to save money. Not good enough.

Our (usually) monthly meetings were suspended by consensus from December of 2006 until April of 2007 in order to effect cost savings for the USPS and Western Area. Still not enough.

Western Area was being told by the management Co-chair that "WAJSC craft members won't even discuss cost saving measures." As you will note in the preceding paragraphs, that was simply not true. We were agreeing to make cuts wherever possible-within reason. We would not, however, agree to cuts that would render the process essentially useless. Below you will see that is what management eventually attempted.

The craft members of the WAJSC were being subjected to very heavy pressure and harassment in an attempt to force us to consensus on several issues, including doing DJSC reviews via telephone/ teleconference. We drew the line on this idea. We refused to come to consensus. It is impossible to determine whether or not a DJSC is fulfilling its

oversight obligation, the quality of the projects that are being done or if the group is working well together when doing a telecom. Oversight is over, without sight. Subtle body language is key to evaluating the group and it is difficult, if not impossible to pick that up via the telephone/ Internet. In the past, our group had recognized problems with more than one DJSC by noticing subtleties. Even though they "talked a good game" we knew they were in trouble because of the way they interacted. We were able to intervene and make improvements as a result of our observations—observations that would not have been possible but for meeting with the groups face-to-face.

Once we made evident our position on telecoms, we faced a flurry of insults from the management members of the WAJSC. Insults that included (and these are quoted directly from my notes) "crybabies", "spoiled brat", "you guys are having a 'temper tantrum", "you're not leaders if you don't agree to change", "the WAJSC is irrelevant", "the WAJSC doesn't do s\_\_t". There was more that I didn't get written down in my notes since I was quite involved in the... "discussion".

The class provided by the WAJSC that trained new members (craft and management) in the QWL/EI process was cancelled and re-scheduled at least twice and eventually, suspended. We did not come to consensus to stop the training. Management dictated by refusing to fund it. By the time the process died many dozens of carriers and managers were waiting to be trained.

In the end, management was attempting to dictate:

Where meetings took place (Denver, because management members lived nearby).

Reviews would be done electronically unless a DJSC was in "trouble" (management presumably determining who is in trouble).

Which members would attend certain reviews (only enough to make a quorum, with others possibly attending electronically).

How often trainings took place. Where trainings took place. Whether there was an annual meeting with DJSCs (Forum) and who would, and would not, attend such meetings. How many hours the WAJSC coordinator needed to do her job (a 24 hour/week job became 16 hours/week, by decree of the management Co-chair).

One of the lynchpins of the QWL/EI process is that decisions are made by consensus. Consensus means that all members either agree or that they "can live with" the decision that the committee has made. If there is a single dissenting member, the committee's decision is void. BUT; management added caveats: "There is no consensus when it comes to money" and "It's Sylvester's money" (reference is to Western Area Vice-President, Sylvester Black).

"It is CRITICAL to ensure the momentum of the Process be maintained and where a temporary disruption is necessary it must be done by consensus. The QWL/EI Process is a long-term investment in the future of our organization, and it is not one which is appropriate for short-term ":knee jerk" reactions."---QWL/EI National Guidelines, Page 7 (Emphasis mine)

Before the Process was ended, Western Area had replaced three of the four management members of the WAJSC (before their terms expired) with personnel from Western Area and had put in place a new (acting) coordinator—also from the Western Area. We always met in Denver at Western Area Headquarters. It appeared to me that Western Area was attempting to gain better control of its team and the pressure was again beginning to build to deal only with what it wanted us to deal with...cost savings and postal revenue. Since the "reorganization", we had done no real DJSC reviews and provided no training.

The goal of QWL/EI (remember these goals were written jointly back in 1982-83, when the process began) "...is the commitment of an organization

to work toward improving and providing more satisfying and effective jobs and better work environments for people at all levels of the organization. QWL/EI encourages a climate in which people respect one another, treat each other fairly, and seek to solve problems cooperatively, helping one another and the organization grow and develop together." (Emphasis mine)

Though it is certainly incorporated in the goal, there is no specific mention of "increasing revenue" in the Guidelines, even as revised in 2004. But in the end, that appeared to be the ONLY goal of Western Area and thus, the management part of our committee. In the end, it was the management part of the committee who showed a lack of leadership by not standing up to the dictates of Western Area, which ran counter to the goal of QWL/EI.

I wish the Process could have continued but it was becoming increasingly lopsided in its goals and when consensus is no longer part of the process, we are left with an "employer/employee" relationship (only) again. Perhaps, when there is a turnover in the top levels of leadership in this organization, the Process can be re-started.

- 3. Nominations must be sent to the Vice-President of the Association.
- 4. Decision is to be made at the Board meeting prior to State Convention.
- 5. Recipient must receive more than 50% majority of votes cast.

#### Criteria for Selection:

- 1. The primary consideration of the selection committee shall be:
  - a. The service rendered by the candidate to the NRLCA.
  - b. Attendance and participation in local, state and national meetings.
  - c. Willingness to accept responsibilities and dedication in performing those duties.
  - d. Fraternal attitude to others in the rural carrier craft.
- 2. The Selection Committee should consider, as a secondary matter, other service such as civic and community activities which reflect favorably upon the rural craft and the USPS.


