

NRLCA 105th National Convention

Grapevine, Texas

The 105th convention of the National Rural Letter Carriers' Association was held August 18-21, 2009, in Grapevine, Texas. There were 20 regular delegates and 1 alternate delegate from Washington State in attendance. I'm pleased to report that the delegates from Washington State fulfilled all duties associated with their position as required by our constitution.



While the convention officially began Tuesday, August 18, there were events, meetings, and seminars available to the more than 2,500 attendees in the days leading up to Tuesday and into Tuesday evening as well. Informational seminars were available on: Legislative issues, Thrift Savings, Office of Workers' Compensation Programs (OWCP), Automobile Insurance (GMAC), Rural Carrier Academies, Insurance Programs, and Pre- and Post-Retirement and Retirement Financial Planning (for both the Federal Employee Retirement System (FERS) and the Civil Service Retirement System (CSRS)).

In addition to all of the seminars mentioned above, there was a 3 hour session on Monday during which we received

a comprehensive overview of current issues, especially those issues of immediate and pressing concern in the labor/management, legislative, and legal forum.

The opening session, on Tuesday, August 18 began with the "Parade of States," a moving recognition of all the state associations comprising the National Rural Letter Carriers' Association. This was followed by the Pledge of Allegiance, our National Anthem, and the invocation. We then heard welcoming comments from postal and governmental dignitaries followed by a response from Association and Auxiliary officers.

Tuesday afternoon featured the Outstanding Member of the Year and Auxiliary Member of the Year presentations during which our own Becky Pike was recognized as Washington State's Outstanding Member of the Year, and Sheila Lott received recognition as the Auxiliary Member of the Year.

The Wednesday session opened with a presentation of membership awards, state publication awards and Steward Task Force awards. The Washington Rural Carrier, our state publication, was recognized during the Editor's Seminar with an Honorable Mention for Best Article, "What Has the Union Done for Us?" written by Renee' Cowan, Susie Hill, editor. Also recognized with a 2008-2009 Special Service Award was former WARLCA President Patricia Alexander for her work on the National Constitution Review Committee.

Wednesday also featured an address by Denis Lemelin, President of the Canadian Union of Postal Workers, representing 54,000 members in Canada who face issues similar to those faced by NRLCA members. I encourage all members to read Mr. Lemelin's address in the verbatim transcript of the convention found in the November issue of the National Rural Letter Carrier (Vol. 106, No.11, pg. 587).

Following Mr. Lemelin's remarks, USPS Postmaster General Jack Potter addressed the convention with a comprehensive report of the obstacles facing the Postal Service and its employees. This was followed by a question and answer period which provided the delegates an opportunity to ask questions directly of the Postmaster General.

Wednesday afternoon, through Thursday, and into Friday morning the delegates addressed the "meat and potatoes" of the convention; proposed constitution changes, and resolutions, both binding and non-binding. One thing that was very evident during the course of discussion, debate, and decision making; the membership as a whole was adamant that we oppose any attempt to move to 5-day delivery of the mail, and that we embrace 6-day delivery.

Friday brought the election of NRLCA officers. Those officers who were elected at the 105th National Convention are as follows: President, Don Cantriel; Vice President, Jeanette Dwyer; Secretary-Treasurer, Clifford Dailing; Director of Labor Relations, Joey Johnson; Director of Steward Operations, Ronnie Stutts; and Executive Committeeman, Robert Horne. Something Else You Need to Know Becky Wendlandt

Ever wonder what is on file with the USPS concerning you and your work history? Now is the time to check it out! Also time to make sure it is correct, because 10 years from now, when you want to retire you want it based on the correct dates and figures.



I know, because the USPS "lost" my records when I first became a regular carrier in 1991. I had to "prove" that I had 10 years as a RCR/RCA. My pay stubs served as this proof. Now I know not all of you keep your pay stubs, so let's start now making sure you are credited with all you have coming to you for your retirement! First of all, you need to have a pin number for Lite Blue. If you don't, create that on-line at the Lite Blue website (shown below). After you get your pin number, check out all the information at eOPF file. You will be surprised what is there! The most important report is the RTR (Retirement, Thrift, Retention) Employee Detail Report. See below how to read it and what it means to you!

Now is also the time to think about being a delegate to State and National Convention. If you want to be a delegate to State Convention attend your annual county meeting and put your name on the list for the delegate election. It is that easy. If you want to be a delegate to National Convention complete the nomination form in the National Rural Carrier Magazine (February, March, April, May issues). Even if you don't want to be a delegate, plan on attending in Spokane to hear the National Speakers on issues of retirement, health care, OWCP, Thrift Savings, etc. You will find the agenda of when they speak in the upcoming National magazines and

also on the NRLCA.com website. It is a chance of a lifetime to attend these seminars and be able to ask questions directly with the speakers. It is your career, so it is up to you to take charge of it.

Now that we are all one "happy" family (Seattle and Spokane districts are now under Seattle District) we in the former Spokane district have noticed an increase in micro-managing. It is amazing that rural carriers have been able to do their jobs all these years without someone who has never been a Postmaster, clerk, or even delivered mail, telling us how to do the job correctly. I used to call it, "The Idea of the Year", now it is more like "The Idea of the Month". Meanwhile we continue to do the right thing, deliver our mail safely, take care of our customers, and try not to get too upset over stupid things. I am proud of rural carriers! Keep up the great job and remember; "This too shall pass". Keep doing the right thing, be safe, and don't take your job home to your family and loved ones.

Enter your USPS Employee ID (8 digits and on the top of your pay stub)
Enter your USPS Employee PIN
Log on

Look on the right hand side under Employee Resources and log on to eOPF.

You will need to enter your USPS Employee ID number and USPS Employee PIN again.

Under "form ID" look for RTR and under "description" look for RTR Employee Detail Report. Click on this report and print it out.

Make sure the RTR report has your correct social security number under EMP #. Do not worry that the EMP ID number (6 digits) is not your correct USPS employee ID number, but the social security number MUST be yours.

On this report will be a LOST TIME print out if you have taken any leave without pay. Any

year showing over 1040 hours (130 days) will be important to check because each day over 130 days sets your retirement date back by each day over.

Also on this report is the WAE (When Actually Employed) Time. Check to make sure these dates and hours are correct.

Toward the end will be your "Calculation Results". This gives you the retirement computation date (RCD), annuity computation date (ACD), reduction in force computation date (RIF), and Thrift Savings Plan Computation date (TSP). The TSP is also sometimes listed as TSP/SCD which stands for Service Computation Date. Make sure all of these computation dates are correct.

WRLCA BOARD MEETING

October 26,27, 28, 2009 Bellevue Hilton, Bellevue, WA

MEMBERS IN ATTENDANCE: Patrick Pitts, President; Cheri Freeman, Vice-President; Becky Wendlandt, Secretary/Treasurer; Susie Hill, Editor; Becky Pike, District One; Renee' Cowan, District Two; Cindy Koker, District Three; Ed Ogdon, District Four; and Joyce Patteson, State Steward.

President Patrick called the meeting to order at 8:45 AM on October 26, 2009. After a brief positive go around, we reviewed the agenda.

<u>Minutes and Tasks Report:</u> The minutes from the July 13-17, 2009 meeting were read and approved. Each task was reported out and those not completed will be added to the tasks report from this meeting. The board also reviewed the board policy.

<u>Fall Kick Start Rally Recap:</u> The Fall Kick Start Rally in Bellevue on October 25, 2009 with miniseminars was a success. Ninety four members were in attendance. It was decided to have one in Spokane in conjunction with the East Central Washington County meeting on November 22, 2009 from 11AM to Noon – no host brunch and Noon to 3 PM meeting. Also planned was another meeting at the Benton PUD in Kennewick from 1 PM to 4 PM on November 15, 2009.

<u>Washington Rural Carrier:</u> The <u>Winter Issue</u> will be to the printer by January 25, 2010. Articles are to be sent to Susie by January 10, 2010. The <u>Spring Issue</u> will be to the printer by March 15, 2010. Articles are to be sent to Susie by March 7, 2010.

Full Time Employees: The board discussed the work load for full and part time employees. Cheri and Becky were voted to be full time for 6 months (last 3 months in 2009 and first 3 months in 2010). This will take care of being over 130 days for 2009 and 2010 year. Some of these days will be used for and charged against the 2010 National Convention account.

Equipment Review: The board agreed to purchase 2 Brother MFC All in One Copies from Costco for Renee' and Cheri. Renee's current brother has died and Cheri's will be used for State Convention.

Planning 09/10 Year Meeting Dates and Location:

Steward Trainings:

- New Local Steward Trainings: Train on an as-needed basis. Compensation will be \$150 for attending the full training. If a member is in the process of becoming a local steward in their office and WARLCA has a local steward training planned, that member can attend but will not get paid until they are certified as a local steward in their office.
- Local Steward Enhancement Trainings: Restricted to local stewards as per National instructions. Compensation will be \$150 for attending the full training. All attending will be notified to bring their lunch.
 - May 16, 2010 (Sunday) from 10 AM to 5 PM in the Pasco area. Joyce trainer.
 - May 23, 2010 (Sunday) from 10 AM to 5 PM in the Everett area. Patrick trainer.
- **Regional State Level Steward Training:** Training will be in Las Vegas, NV November 17-19, 2009 with travel on November 16th and 20th. Joyce, Monte, Patrick, Cheri, and Renee' will attend.
- National State Steward Training: Joyce has not heard when this will be. Cheri is the next steward that needs to attend.
- Mail Count Trainings/District Meetings:
- ➤ January 18, 2010 (Monday Holiday) in Spokane, WA at the Red Lion Hotel at the Park from 10 AM to 4 PM (bring lunch-short break). Afterwards, go into 1 hour District 3 meeting from 4 PM to 5 PM to include campaigning. Cheri will be the trainer for the mail count training.
- ➤ January 31, 2010 (Sunday) at Benton PUD in Kennewick, WA from 10 AM to 4 PM (bring lunch-short break). Afterwards, go into 1 hour District 4 meeting from 4 PM to 5 PM to include nominations and campaigning. Joyce will be the trainer for the mail count training.
- ➤ January 31, 2010 (Sunday) at Stanwood Masonic Center, Stanwood, WA. Meeting from 9 AM to 4 PM (bring lunch- short break). Afterwards, go into 1 hour District 1 meeting from 4 PM to 5 PM to include campaigning. Patrick will be the trainer for the mail count training.
- ➤ January 24, 2010 (Sunday) at the Best Western Park Plaza in Puyallup, WA. Meeting from 9 AM to 4 PM (bring lunch- short break). Afterwards, go into 1 hour District 2 meeting from 4 PM to 5 PM to include nominations and campaigning. Renee' will be the trainer for the mail count training.
- ➤ January 18, 2010 (Monday-Holiday) at Longview PUD, 961 12th Ave., Longview, WA, from 10 AM to 4 PM. (Bring lunch short break). Monte will be the trainer.
- ➤ January 18, 2010 (Monday-Holiday) at the Douglas County Fire District #2, 377 Eastmont Ave., East Wenatchee, WA, from 10 AM to 4 PM. (Bring lunch-short break) Joyce will be the trainer.

Board Meetings:

- SPRING: Travel on morning of March 22, 2010 (Monday). Board Meeting on March 22, 2010 from 1 PM to 5 PM, March 23, 2010 (Tuesday) from 8:30 AM to 5:30 PM, March 24, 2010 (Wednesday) from 8 AM to Noon and travel in afternoon. Overnight stay for all board members for Monday and Tuesday. Board meeting will be at the Wenatchee Red Lion.
- <u>SATURDAY BEFORE STATE CONVENTION:</u> The board will meet Saturday, June 19, 2010 at the Red Lion Hotel at the Park, Spokane, WA from 8:30 AM to 5:30 PM.

National State Secretary-Treasurer Trainings:

• None scheduled at this time but usually one is held in the Spring, possibly at the National Office in Alexandria, VA.

National Legislative Seminar:

 Legislative seminar will be in DC in May, 2010. Patrick and Cheri will attend. Patrick gets paid mileage and hotel by National, and the WARLCA will pay for ADOP. WARLCA picks up all costs for Cheri.

State Secretary-Treasurer Report and Planning Budget for 09/10:

<u>Membership:</u> No reports from National since June, 2009. I have sent letters to all relief non-members that I have on file and after getting a "What attending a mail count training can mean to you", I will be sending recruitment letters to all non-member regulars that I have on file.

<u>Financial</u>: We need to not only be aware of our budget and finances this year but start planning for the 2010 calendar year for LWOP. The board reviewed the financial statement and worked on the budget.

<u>I.C.E.</u> (In case of emergency): The board agreed to use the final format of the I.C.E. and will complete it and send it to Becky.

State Steward Report: Joyce presented to the board a detailed steward report handout. We have 42 local stewards currently. Joyce said the training for the 2 new area stewards would be two days. Although they may be mentored by an assistant, they are to report directly to the State Steward. The area stewards will have a 6 month term.

Grievance Report:

Step 3, 13 grievances appealed to Step 3 since last board meeting – 10 contractual, 3 discipline (2 removal, 1 emergency placement, 4 Step 3 decisions have been received, and one grievance has been closed out).

Step 2, approximately 20 grievances currently at step 2 of which approximately 5 are disciplinary including 2 removals. Approximately 26 grievances have been settled at Step 2 since last board meeting, 1 held in abeyance, and 2 remanded.

Step 1 (at state level steward level), 16 total, 3 are disciplinary.

Approximately 38 grievances settled at Step 1 of which approximately 8 were disciplinary including 2 removals.

Seventeen vacant routes in 15 post offices in Seattle District are being held for consolidation.

State Convention 2010: Ed will be the chair for State Convention 2010 at the Red Lion Inn at the Park on June 20-23, 2010. The board reviewed the registration form and decided to have the District Representatives, the Editor, and sec/tres be the registration committee. Patrick announced he would like to assign a photographer, and also to bring in 3 people for the teller's committee on Saturday. Consensus to leave the dollar cap at \$25,000 for State paid convention delegates to the 2010 state

convention. Consensus to only have the NRLCA National officer as a speaker.

<u>State Convention 2011:</u> Contract is signed for Gig Harbor Inn on June 27, 28, 29, 2011 for state convention and Saturday, June 25 for a board meeting, Sunday, June 26 for steward training/membership breakouts. <u>State Convention 2012:</u> The board will be checking out the Red Lion in Wenatchee for a possible site for the 2012 State Convention. Discussion on whether it could be trimmed down to a 2 day convention instead of 3 days. <u>State Convention 2013:</u> State Convention 2013 will be in District One. Becky Pike will be checking out locations.

County Units: The last day to hold the annual county meeting is May 12, 2010.

Assignments (Appointments): President Patrick made the following appointments: Ed Ogdon will be the historian. Ed will notify members and request any history.

<u>Vouchers:</u> The board reviewed last quarters vouchers.

<u>National Convention 2010:</u> Cheri and Becky updated the board on the planning for 2010 National Convention.

- ➤ Discussion on junior sponsors for 2010 National Convention and Jeanette Dwyer confirmed that it is solely the responsibility of the National Auxiliary.
- > The board approved the design of the logo by Susie's nephew. It will be used on the ditty bags as well as the back of the vests for the workers.
- ➤ The board reviewed each line of the spreadsheet for the committee members time, hotel, mileage, days used, responsibilities, etc for each committee and the budget.
- ➤ Joyce updated the board on the golf committee. It is the only committee not funded by National now that we no longer have a country store. She said she is looking at Indian Canyon, Downriver, and Meadow Wood golf courses.

When The Sun Comes Out.....

About ten years ago I went to Kenya in southern Africa to spread the ashes of my father. He had been a missionary to South Africa building churches and when he died my mom and I went there to plant a tree at each of the seven churches he had built and "fertilized" the tree with a bit of dad.



Where this took place was right on the equator, 8000 feet above sea level. I am very fair-skinned and when I came home I started having problems with dry patches on my face, ears and the top of my head. I went to my family doctor who burned them off with liquid nitrogen because they were pre-cancerous. The patches kept coming back so I went to a dermatologist and, although he too burned them off with liquid nitrogen, he burned them well enough they did not come back. Eight years ago my doctor found and removed a small basal cell carcinoma from my nose.

By then I was already wearing hats that completely covered my head, ears, neck and the sides of my face but I was told that the damage to my skin started in my childhood. It turns out that skin damage is cumulative and the dry patches I was experiencing was a result of my skin being too damaged to repair itself correctly. I have been going to my skin doctor twice a year since then. This past August I went in with about 20 new dry patches and an itchy spot on my leg. My doctor wanted to take a biopsy of two dry spots and the spot on my leg. One of the dry spots came back as squamous cell carcinoma. When my basal cell carcinoma was found eight years ago it was just a very small spot (about the size of a pin head) that would not heal. It just kept forming a scab and never healing over. The squamous cell carcinoma they just found was about the size of a dime and looked just like all the other dry patches of skin I have been having

removed for the past ten years. No coloration, no bump, nothing but a tiny dry spot on my right cheek! Sixteen stitches later and a cheek with no feeling to it I am now once again cancer free. Our job requires us to be out in the sun so please, if you are of fair skin, or have developed new "spots", or are over 50, please go see a skin doctor to have a total body cancer check. I got lucky, I see a skin doctor on a regular basis and it probably saved my life. Are you pressing your luck?

Dispute Procedures for Mail Count

By the time you read this, the 2010 National Mail Count will have either already begun, or will be right around the corner. Hopefully you were able to attend union-sponsored mail count training. If so, you have already learned how to dispute items for mail count and this



will be a refresher. If not, then you will at least have this information.

It's extremely important that you understand the correct procedures for disputing items during and after mail count. Too often, we don't have enough information and/or documentation to correctly process a grievance over a mail count disagreement and/or dispute. This leads to much frustration for all of us—especially you because your grievance either gets settled with language along the lines that management will follow proper count procedures as laid out in the handbooks and manuals, or you end up not filing because you just don't want to take the time to properly document your disputes.

If you have a dispute with management over the way a particular item was counted, you must bring it to their attention immediately—especially if it involves mail that is to be delivered that day. Explain to management why you disagree with the way he or she counted it. Hopefully, if you have a reasonable argument, they will change the way the item is recorded and you can move on. Unfortunately, this usually is not the case. If management maintains that it was counted correctly, calmly and respectfully explain to them that you still disagree and ask them if they will document the mail piece with you. If so, you can document the item, and if not, you will have to document the item yourself. You will need to document everything you can about the item such as what the mail piece is including all dimensions; the class of the item i.e., first class, second class, bulk rate, etc.; any special endorsements that are annotated on the item such as "Do Not Bend"; and how many pieces there were if there is more than

one like item.

If you are disputing a mail piece that management counted as a letter or flat and you believe it to be a parcel based on the fact that it won't fit in a twoinch separation with other mail, there are other things you will need to document as well. In this case, we will also need documentation of all the "other mail" you have already cased in the twoinch separation. If the item in question is a rigid article in a flexible mail piece, we need both the dimensions of the rigid article and also the flexible mail piece. We also need to know if management used "extraordinary efforts" to relocate and/or rearrange the rigid item in the flexible mail piece in an attempt to case the mail piece. Management may not require this from a carrier and shouldn't be doing it themselves either.

You should keep a dispute sheet for each day of the mail count that you have disputes. If management is willing to assist you with the documentation, please have them sign the dispute sheet. This will indicate that they agree with what you have written down as documenting the disputed item, and this makes our case stronger. Hopefully management will understand that by signing, this doesn't mean they are in agreement with the dispute itself; it simply means they agree with the documentation.

Once mail count is over, management will provide you with a 4241x. Contractually, you have two days to check the 4241x for accuracy. You should be checking your 4239 on a daily basis prior to leaving for the route to make certain that all entries have been completed up to that point. You should also be checking them on a daily basis to make sure the totals are accurate. If either one of these are not correct, it needs to be brought up to management immediately. Entries on a daily 4239 can't be checked once the sticky notes are gone. If you have been verifying the totals on your 4239s, it will be easier to verify the totals on the 4241x.

After the two day period, management will want to go over the 4241x with you and ask you to sign the form. There are two places you can sign. One is for election of high option in case you end up having a choice between high option and low option, and the other is whether or not you certify the count to be correct. If you have disputed any items, you do

not want to sign that you certify it to be correct. If you do not sign, you need to submit a letter explaining why you disagree with the count data. This letter should be professional in nature, and explain precisely with as many details as possible why you disagree with the data. Your letter will be submitted to the district along with the 4241x. Management is also supposed to submit a letter explaining their side of your disagreements.

After what is supposed to be a reasonable amount of time, management and/or you will receive a letter from district personnel regarding your letter of dispute. Your local management will usually write a letter to you explaining the district's position although sometimes they don't. Either way, once you receive that letter from management, it begins the 14-day window of opportunity for you to initiate a grievance or grievances on your disputed items. Please—if you have any questions on this process at any point during or after the mail count, contact your assigned steward for assistance. This may be a Local Steward if there is one in your office, an Area Steward, or your assigned Statelevel steward. Again, without good documentation it's nearly impossible to prevail in the grievance process.

Why Didn't My Evaluation Go Up When I Turned In My Edit Book?

The Edit Book does not trigger the changes in your 4241-A (Rural Route evaluation). It is the information on the top of the 4003 (line of travel) that trigger the changes in a 4241-A and also results in a change in evaluation when appropriate.

In the past, AMS (Address Management System) would not accept the Edit Book without it being accompanied by an updated 4003. Therefore, whenever the Edit Book was submitted, the changes were made in the system that would produce an updated 4241-A. If the changes amounted to a change in evaluation, that change was made. If not, the changes were reflected as banked time—either plus or minus.

With all of the changes in the districts, etc., the process has now changed. The Edit Book and the 4003 are not going to the same department to be processed. In most cases the local managers are not taking the time to update the 4003 and sending it to OPS (Operations Programs Support) and thus the changes in route evaluations are not taking place. Unless the carrier is aware and realizes he or she should have had an evaluation change and presses management to correct the situation, the evaluation will remain the same.

As rural carriers, we tend to rely on management to take care of our route statistics. We take care of our Edit Books—add and delete the boxes as required and when there is enough growth to give us another hour we expect that management will process the proper paper work to get it done. Rarely do we question our managers when don't receive an updated 4003 or 4241-A that shows how much time is in the bank towards the next change.

Growing Labor Unions Will Grow Our Economy

Ask anyone, and they will tell you that the subprime mortgage mess brought down our economy. Otherwise, the economy was "fundamentally sound." I'll agree that tanking mortgages pushed us over the edge, but the subprime train wreck was only a symptom of a much larger problem. If subprime mortgages hadn't got us, something else would have.

Here's what I think happened. Beginning around 1980, labor union strength began to decline and wage growth slowed dramatically. For a while, working families compensated by having more family members take jobs, but eventually stagnant wages and rising costs took their toll. More families became trapped in debt as they tried to maintain a middle class way of life on wages that were no longer up to the task.

Even though wages were stagnant, American workers continued to become more and more productive. This is something all of us can be proud of. But since there were not enough labor unions to bargain that productivity into higher wages, super wealthy owners fattened up on what otherwise would have gone to middle class families. Since 1980, the share of wealth and income going to the upper one percent of Americans more than doubled.

As the super-rich got even richer, they became more powerful. They changed banking rules to allow them to play fast and loose in ways that were once illegal.

They changed the tax system in ways that would benefit them at everyone else's expense. Rather than build factories that put Americans to work, they sent jobs overseas. Rather than pay workers middle class wages, they lent money to middle class families on increasingly risky terms.

Now we have the witch's brew: one part working people struggling to stay in the middle class, one part the gains from productivity growth going to the wrong people, and one part unimaginable fortunes chasing short term gains at any cost. We shouldn't be surprised that when Big Money met underpaid workers, the result was too much debt and too much funny money for the overall system to bear.

Looked at this way, we have a big policy problem. If we continue treating symptoms instead of problems, as we are now doing, the best we can hope for is to put things back the way they were. If we do that, we will have more rogue banks, more people without middle class incomes, and more fat cats running both Washington and Wall Street.

Lasting recovery will come only when we start treating the problem: without middle class wages, there is nothing "fundamentally sound" about our economy. We must grow our labor unions so they can do what only labor unions can do: keep the gains from worker productivity in the hands of working people.
