

State of Our Union

It is more important than ever to be an informed rural carrier.

We are working in an extreme working climate where managers are being pushed to cut down hours and spend as little as possible to get the job done. At the same time, managers, especially new managers, have to learn their jobs by the seat of their pants. What little training is available is only online and the managers have to find the training time during working hours while



doing all the other required duties. Is it any wonder that they're making contractual mistakes? Is it any wonder that they don't realize some directions coming from Seattle might not be contractual? Rural carriers need to know their own contract and their rights guaranteed therein. If you get an order or a new duty and it doesn't "feel" right, call your steward and find out. Don't take your manager's word for it. Check it out. Remember – you have 14 days to file a grievance! Your steward, local or assistant, can find out the facts. You can also research answers to your questions on the NRLCA Website: www.nrlca.org and the WARLCA Website: www.wwrlca.com.

Negotiations on our contract have broken down and arbitration is looking very likely. There is legislation that was brought forth in the previous Congress that would take the neutrality out of the arbitrators' hands. I am confident that with the failure of

Congress to pass any relief for the Postal Service's requirement to pre-fund future retiree's health benefits and thus the Postal Service's continuing financial spiral downward, this legislation will be put on the table once again. Another Congressional action could change the delivery days from 6 to 5 when they vote on the Appropriations (Budget) Bill. One of the Union's functions is to lobby Congress on our behalf. We have PAC funds that we use to support candidates who vote positively on our issues or reflect our views in their campaign statements. Our lobbyists do not care what political party a candidate, Representative, or Senator is affiliated with. We give money and support to the people who have supported us, the Union worker. Due to Congress' control over the USPS, it is the Union's responsibility to inform the membership which candidate has embraced our view of our issues. The Union does not require that any association member vote for any particular candidate but we want you to be an informed voter. You can help by writing letters to your Congressional representatives and by sending a donation to PAC.

I would like to take this opportunity to discuss how your State Board operates. The board is made up of the President, Vice Pres., Sec./Treas., and four District Representatives. All meetings have an agenda that is sent out prior to the meeting for review, comments, and additions. Consensus is the goal for all decisions but if, after everyone has had a chance to address the issue and consensus is not reached, a vote is taken. Once the majority has decided it becomes a 'board decision' and everyone agrees to abide by it. You have elected a strong, diverse, and verbal board. While we have many opposing opinions, we all respect each other and have shown remarkable ability to discuss difficult issues, disagree, come to a decision, and move on to the next issue. We take our responsibility to do the work of the Association very seriously.

The board has prioritized our business meetings into Duty of Fair Representation and oversight of the budget. The largest expenditure is the steward system. We now have many unfunded but mandated

responsibilities placed on us by our National Board. All State Level Stewards are required to have an association-provided computer 5 yrs old or newer, cell phones, and multifunction fax, scanner, copy machines. Your board reviews the requirements at each meeting and tries to schedule replacement only when necessary and when we can find the necessary equipment on sale. In order to reduce the cost of board meetings we have reduced each board meeting by a minimum of one full day or more. The budget is reviewed at every meeting and any expenditure requested between board meetings is discussed and voted on by emails.

The next board meeting starts March 27 at Federal Way. If you have any items you wish to be addressed please send me a hard copy letter (support our jobs) on or before March 18 so it can be placed on the agenda.

It is winter and the roads are crowded, wet, icy, snowy and just plain yucky. There have been many reports of rural carrier accidents, including those with injuries. Remember that your goal, every day, should be to go home to your family! BE SAFE!

Hello all future Provident Guild members! After attending the Provident Guild meeting at the National Rural Letter Carriers Convention in Spokane this year I am happy to give you the opportunity to join this fraternal organization



that was created and is operated by rural carriers for all members of the NRLCA and their spouses, if they are a member of the Auxiliary. You may join at any level regardless of age classification as long as you are under the age of 56 or under the age for the class. You will always remain a member as

long as you keep your annual dues of \$10 to \$50 current even if you leave postal employment. There is a \$2 entry fee. The payout upon the death of the member can range from \$1000-\$5000 depending on the original class you enrolled in with 30% being available immediately. You will need to notify the secretary of the Provident Guild at the address listed on the bottom of your last dues receipt within 60 days with a copy of the death certificate. If the death occurs in June the claims need to be in their hands by July 30th or no benefit will be paid in either case. Benefits do not decrease as you grow older. This is a bargain for today's market. You do not need a physical and you will not be cancelled at age 65.

Updates from Becky

Does anyone up at postal headquarters really care about saving the USPS?

You would think with the increased number of managers the USPS has that they would catch this before it happens. But apparently, it keeps



happening even after the OIG reported on previous problems. From PostalNewsBlog:

"OIG: USPS wasted \$35 million sending first class mail via FedEx

The US Postal Service Inspector General has found that the USPS is paying FedEx to transport and sort First Class Mail that could have been handled more cheaply by surface transport, the airlines, and postal employees. The audit covered transportation costs in the Capital Metro, Eastern, Great Lakes, and Northeast Areas.

The OIG's report found:

It was more effective and economical in some cases for the Capital Metro, Eastern, Great Lakes, and Northeast Areas to use ground transportation and domestic air carriers as well as to sort mail at Postal Service plants than to use FedEx to perform these functions. Because the areas used FedEx, the Postal Service incurred about \$35.3 million in unnecessary costs. If these areas implement our recommended changes, we estimate the Postal Service could save \$170.6 million over a 10-year period.

Previous OIG audits identified \$390 million in potential unnecessary charges due to the use of FedEx in other areas."

USPS is broke, except for a few!

I work in a cement block building that has asbestos in it. But NOT those who decide our future and THINK they know how we should do our jobs (after 30 years I think I can figure it out, how about you?) So here are the perks for the rich who are getting richer on our work! If headquarters really wanted to save the USPS why don't they sell that prime location and move to a cheaper building on

the outskirts of DC, or better yet, put headquarters in a mail plant so they could really see what is happening!

"<u>USPS OIG plans to spend \$5 million to renovate</u> its headquarters

Solicitation posted by the US Postal Service Office of Inspector General:

The United States Postal Service (USPS) Office of Inspector General (OIG) plans to issue a Firm Fixed Price Contract for a multi-phased Office Renovation to their Headquarters facility located at 1735 N Lynn Street, Arlington, VA. The work includes all labor and materials necessary to complete the renovations in accordance with USPS OIG approved specifications and drawings. Proposers should recognize the building is occupied and the project will be completed in multiple phases to avoid disruption of facility operations. The estimated cost of the project is between \$4.8 million and \$5.6 million, with construction completion within 365 calendar days from receipt of notice to proceed for the total project. The project consists of renovating 123,126 interior sf in an existing 12-story commercial office building. Work includes demolition and new work on 6 floors. Demolition work includes but is not limited to, interior partitions, casework, acoustical ceilings, lighting, mechanical diffusers and plumbing fixtures. All mechanical ductwork shall remain. New work includes new gypsum board partitions, new finishes throughout including; acoustical ceiling tiles, gypsum bulkheads, painted walls, broadloom carpet and vinyl tiles. Work also includes new lighting, electrical and IT wiring throughout and limited mechanical, plumbing and sprinkler work."

Want a 2% pay raise?

You are getting a 2% raise in your pay thanks to Congress. Due to the recently passed Tax Relief, Unemployment Insurance Reauthorization, and Job Creation Act of 2010, FICA tax rates are being cut by 2% for employees for the year **2011 only**. What this means is that the FICA (**Federal Insurance Contributions Act**) tax that was normally 6.2% of our gross pay is now 4.2%. So if your gross pay is \$1200 a pay period the tax will now be \$50.40 taken

out instead of \$74.40, thus giving you \$24 more in your take home pay per pay period, or \$624 for a year if your gross pay is \$1200. Finally, some good news!

USPS Pay Stub Details:

Check out the USPS lite blue website at www.liteblue.usps.gov/wps/portal/!ut/p/.scr/Login Login with your employee ID and your pin and check out Employee apps – Quick links. Look for your epayroll and click on this. You will find the complete detail on your pay. It is lots easier to read than the paystubs we receive.

Also on the same website go to eOPF – check out your dates for accuracy on the Form 50 and RTR!!! This is what is going to be used to figure step increases and retirement so make sure it is correct.

Do you wonder what the future holds for you as a rural carrier?

I sure hope you do, because your future is up to you. Want to know what is happening with the USPS, our contract, future pay, benefits, retirement, rules, ema, etc? The only way to find out is to attend your State Convention and hear what our National Officer has to say. Plenty of time to get answers to your questions from our National Officer who knows the answers and works directly with the USPS headquarters. Let your National Officer know what is happening in your office at State Convention. To be a paid delegate to state convention the first step is to go to your annual spring county meeting and ask to be a delegate. All first time attendees say they learn more at the state convention than all of the year at the USPS, and they learn the facts, not just rumors! You will be welcomed and your opinions are valued.

Remember, what happens in the office and on the route stays there. My mom use to say when you go home it is time for you, your family, and your critters. Don't let USPS issues steal away your joy and time with your family. (I say this every day to myself on the way home, it is an on-going work in progress.)

The Eyes, The Ears, and now The Voice

Many of you have stood as the eyes and ears of the Union in your local office. Your state-level stewards have relied on you to make them aware of improper instructions given by local managers, scheduling problems, contractual violations, etc. I cannot understate how



very much your diligence in ensuring the contract is followed and carriers are treated properly is appreciated. Without your eyes and ears I have no doubt that many improprieties in local offices would go unnoticed, and unchallenged by the Union.

In December of 2007 there were 61 local stewards in Washington. As of January, 2011, that number is down to 46. In every office with rural delivery there exists one person, and quite often there is more than one, who possess the skills, drive, and determination necessary to serve as the local steward. **Your Union needs you!**

Local stewards receive training at the state level prior to being certified as a local steward, and, once certified, you will have direct contact with an assigned state-level steward who will serve as your advisor; who will lead you step-by-step through the grievance procedure. You do not need to worry about "not knowing what you're doing" because not only will you have the local steward training to get you started, but also the direct contact with a state-level steward for any questions you may have.

As a local steward you will be compensated by the Postal Service for time spent in grievance handling, including the time necessary for investigation and meetings with management. You will also be compensated by the Postal Service for the time necessary to write a grievance. When we have a local steward in place in a given office, the Postal Service bears the financial burden at Step 1 of any grievances that arise in that office. Without a local steward, the financial burden is borne by the Association.

The process of becoming a local steward is quite simple. A form calling for the election of a local steward is posted in your office for a minimum of 15 days.

During this 15-day period, any Union member can place their name on the form indicating their desire to be considered for the position. At the end of the 15-day period, at the time and place identified on the form, an election is held and the person receiving the majority of the Union member votes cast is elected as the local steward. You will then be scheduled for the new local steward training. The steward election form (Form 10) is available on the NRLCA website. Once you have logged on to NRLCA.org, navigate to "Steward Operations", click on "References" and then "NRLCA Forms" and select "Form 10." You can also obtain a Form 10 from any of the state-level stewards.

Now is the time. You have served as the eyes and ears of the Union; it's time for you to serve as the voice in your local office.

Feel free to contact me with any questions you may have. I look forward to welcoming you to the steward-ranks of the Washington Rural Letter Carriers' Association.

OCTOBER 16-17-18, 2010 MINUTES FROM WARLCA BOARD MEETING Best Western, Ellensburg, WA

MEMBERS IN ATTENDANCE: Cheri Freeman, President; Becky Pike, Vice-President; Becky Wendlandt, Secretary/Treasurer; Renee' Cowan, District Two; Cindy Koker, District Three; Ed Ogdon, District Four; and Patrick Pitts, State Steward. Susie Hill, District One not in attendance due to prior engagement.

President Cheri called the meeting to order at 1:00 PM. After a brief positive go around, President's Remarks, and appointing Ed as a timekeeper, we reviewed the agenda. The reading of the ground rules was waived by consensus. The minutes from the July 25-28, 2010 meeting were read and approved. Each task was reported out and those not completed will be added to the tasks report from this meeting. The minutes from the August 12, 2010 meeting were read and approved. Correspondence and board policy was reviewed.

State Steward Report:

Patrick updated the board on ADOP usage, grievance update, current issues, enhancement training, state level steward summit, regional training, and Weingarten cards. Some current grievances are addressing RDSOP and casing equipment. We have 46 local stewards as of this date. Grievance Update: 16 cases pending National arbitration, but none are from Washington State. 42 open cases at Step 4, of which 3 are from WA. 2 WA route consolidations are being held in abeyance. Patrick is working on encouraging Seattle District to hire and putting together a procedure for WA state stewards that will let the board know by the next board meeting of all the grievances in WA State including local.

Upcoming Enhancement training: Two were held in November in Everett and Benton County PUD. **March 6, 2011** at Longview area with Monte being the trainer.

March 13, 2011 at Mirabeau Hotel on Sullivan Road, Spokane Valley with Cheri being the trainer.

State Secretary-Treasurer Report:

- Membership: We are currently at 1853 (down 16 from last board meeting). Becky sent out the membership recruitment booklet to 36 new hires for this year.
- Finances: The board reviews the ADOP usage every month for future use. The financial statement is sent out each month, along with the ADOP usage.
- Constitution Proposed Changes: Suggest that we need to put the full time salary in the constitution like we have for part time. This can be proposed from a county for next year's state convention.
- ➤ Weingarten Cards: Patrick gave the District Reps Weingarten cards to hand out and also will be handed out to the local stewards at enhancement training.
- ➤ The board reviewed the equipment list, contract for full time employees and vouchers for July, August, and September 2010.

Budget: Planning for the 2010 – 2011 Association Year:

Spring Informational Meeting: The spring informational meeting will be at the Hampton Inn and Suites in Federal Way for 80 people theatre style on March 27, 2011 from 1 PM to 4 PM.

National Steward Training: Patrick and Monte will attend National Steward training in Washington DC.

Legislative Seminar: May 21, 2011 travel, seminar May 22, 23, 24, 25, and travel back May 26, 2011 for legislative seminar. Cheri and Becky Pike will attend.

Board Meetings: The spring board meeting will be in conjunction with the Spring Informational Meeting on March 27, 2011 at the Hampton Inn and Suites in Federal Way. Board meeting will be March 28, 2011 and March 29, 2011 from 8:30 AM to 5:30 PM, March 30, 2011 from 8:30 AM to 1 PM.

The <u>pre-convention board meeting</u> will be Saturday, June 25, 2011 from 8:30 AM to 5:30 PM at Gig Harbor Inn.

Website:

Patrick gave the updates on the WARLCA website. Some stats included:

December 15, 2009 to March 15, 2010: 1,566 visits from 629 visitors viewing 6,331 pages with 4.4 pages per visit average. March 15, 2010 to June 15, 2010: 2,179 visits from 944 visitors viewing 10,450 pages with 4.8 pages per visit average. June 15, 2010 to September 15, 2010: 1,989 visits from 929 visitors viewing 9,708 pages with 4.9 pages per visit average. September 1, 2010 to October 15, 2010 we had 30.59% of traffic from new visitors. Only State that has not hit the website is New Mexico. All other states and many foreign countries have hit it.

National Convention 2010 Wrap-up:

The board decided to take the vests to state convention and sell them for \$5 each to committee members first, then others, with the money to go back in the general fund.

State Convention 2011:

Contract is signed for Gig Harbor Inn on June 27, 28, 29, 2011 for state convention and Saturday, June 25 for a board meeting, Sunday, June 26 for informational presentations. The board put a \$30,000 dollar cap on state convention delegate pay. Consensus not to have any speakers except for the National Officer. If there is a junior program it will be before the memorial on Tuesday morning. Sunday before state convention will be just the national officer and steward system.

State Convention 2012:

We have a signed contract for the Red Lion in Wenatchee for the following dates;

Saturday June 23, 2012 board meeting. Sunday June 24, 2012 for informational meetings and presentation by National Officer and other speakers and county officers training. Monday June 25, 2012 start business session of convention and banquet in the evening. Tuesday June 26, 2010 finish business session of convention. Contract is for \$3,200 in food purchase and must meet 80% of 70 room nights to waive the meeting room costs. \$50 fee for set up per room. One free room for every 35

room nights. Price for single queen is \$105.95 (Prices include comp. breakfast and internet). Price for double queen is \$115.95. Triple is \$125.95 and quad is \$135.95.

State Convention 2013:

State Convention 2013 will be in District One. Susie will be checking out locations. Dates will be June 23, 24, 25th 2013 (Sunday, Monday, and Tuesday)

County Units:

The board heard reports from each district representative present on updates on the county meetings.

Becky had submitted each county's E Postcard to IRS and sent copies to the board and to the counties.

Consensus to charge 35 cents a card for State to do the county meeting notice upon request if the county has funds to pay for it.

Washington Rural Carrier:

Next Issue: **January 2011 Paper:** Articles due to Susie by January 10, 2011 and sent to printer by January 20, 2011. **April 2011 Paper:** Articles due to Susie by March 1, 2011 and sent to printer March 8, 2011.
